- Turn in your application and fee before they are testing if possible

### LIABILITY RELEASE/ NO COMPETE CLAUSE

This Agreement executed the date shown on the front by and between Asian Sun, Inc. dba Asian Sun Martial Arts Training Center, herein referred to as the "Schools", and the student, who has caused his/ her signature to be affixed hereto, hereinafter referred to as the "Student".

Enrollee agrees to abide by the rules and regulations governing conduct and operation of instruction sessions, students, and may be changed from time to time, and Enrollee agrees to abide by all such rules and regulations as adopted or hereafter amended. The hours of operation and date of testing/tournament events may be changed at the discretion of the Schools. The Schools reserve the right to revoke or terminate any membership. Enrollee agrees that all exercises and/or courses are undertaken at member's own risk. The Enrollee understands the procedures and exercises involved in instruction and participation as explained to him/her by an associate of the Schools. The Student understands that there is a risk of personal injury involved in the course of instruction, and that Martial Arts is a body-full contact sport and with this knowledge the Student does hereby, for Student, Student's heirs, executors and administrators agree to indemnify, release, absolve, forever discharge and save harmless the School trustees, officers, managers, organizers, supervisors, and all members, agent, representatives, successors, assigns, coaches, referees, trainers, and/or instructors, any and all of them, from all losses caused by accident or injury to the Student, or third persons, who may or may not be a student of the Schools, in the event that either the Enrollee or said third person is injured in any way during the performance and execution of exercises and/or martial arts. The companies owning the Schools and the agents and employees shall not be responsible for damage, lost or stolen articles, inside or outside the facility. The Student, recognizes that there is a risk to personal safety, accepts responsibility of transport to and from the interior of the Schools.

The school reserves the right to amend or add to these rules and conditions and to adopt new rules and conditions as it may deem necessary.

I, the Student irrevocably authorize the Schools, its successors and assigns, and those acting under its authority, to copy, use, publish, for art advertising, trade, or any other lawful purpose whatsoever, photographic portraits, pictures or video tapes of me, in which I may be included in whole or part. Student guarantees that they are not currently training, managing, consulting, or advising any school, club, and/or training facility operated, associated, and/or orchestrated by, and/or affiliated with another similar competing program outside the Schools' association and/or affiliation. Unauthorized verbal, written, or physical transmission of any material contained in this course is strictly prohibited and considered violation of trade secrets. This course is licensed specifically for these Martial Arts Schools and its team.

If at any time I violate any of the following three (3) Rules and Regulations governing the **Asian Sun Martial Arts Training Center**, I agree that the **Asian Sun Martial Arts Training Center** deserves the right to suspend my rank or status.

1. The purpose of the Oriental Martial Arts is to provide improve both mental and physical health and all members must uphold and protect their honor and the prestige of the **Asian Sun Martial Arts Training Center**.
2. Members are forbidden to use the Oriental Martial Arts techniques to provoke or challenge innocent persons and such use will make offending members subject to disciplinary action.
3. **Asian Sun Martial Arts Training Center** is the sole and only judge of my qualifications and achievements in this Oriental Martial Art.
